ANNUAL GENERAL MEETING

The Singapore Ice Skating Association will be hosting its Annual General Meeting on Friday 23 September 2011.

Please note that only Ordinary Members have the right to vote. As an Individual Member you may attend the Annual General Meeting but have no right of vote or nomination. Please submit the Non-voting Members Attendance Form to indicate your interest.

2011 is an exciting year for ice-skating in Singapore as we prepare to grow and expand the sport. With the establishment of Jcube and partnership with Capital Land and the Singapore Sports Council, SISA has embarked with a Vision 1418 as a strategic plan to cultivate an ice culture and vibrant ice skating fraternity here in Singapore. Recognising the important role that clubs can play, SISA has adopted a club based membership framework to better reach out to the community and to meet individual needs and sporting preferences.

Recognising 2011 as a transitional year for SISA, members and partners, SISA will be waiving the INDIVIDUAL membership fees for the membership year April 2011 to March 2012. This is to facilitate the movement to a club base framework and to give clubs the opportunity to prepare for the growth in interest with the setting up of an Olympic size ice rink at Jcube. Members who have paid their memberships fees will have it transferred to the next membership year. Under the new constitution, which was adopted at the last AGM in 2010, individual members must belong to club. Individual members are therefore encouraged to sign up with a club.

Club Ordinary Members that are entitled to vote at the AGM will need to pay the club fee of SGD 80.00 by cheque made out to the "Singapore Ice Skating Association" and submit the following materials:

- Membership database listing
- List of executive committee members with their positions and contact details
- Club Constitution
- Certificate of Appointment to AGM

All forms are to be submitted to the Association's place of business at No 6 Temasek Boulevard, #09-05 Suntec Tower Four, Singapore 038986 by 19 September 2011, 12 noon.

Clubs and Individual Members are requested to update their membership status with SISA by 15 November 2011 in the membership forms included. Clubs without voting rights must also pay their club fee of SGD30.00 when they update their membership status. Clubs or individual members failing to do so will be removed from the membership registrar.

Membership fees will be payable from the membership year April 2012 onwards.
